**ORDER :**

In the Government Order first read above, orders were issued notifying the Andhra Pradesh Public Employment (House Rent Allowance) Rules, 1988. In the Government Order second read above, orders were issued revising the rates of House Rent Allowance as recommended by the Pay Revision Commission, 1993. In the Government Orders 4<sup>th</sup> and 5<sup>th</sup> read above, orders were issued sanctioning House Rent Allowance @ 12½% to the employees working in the various towns which have crossed 50,000 population considering the rapid urbanization and consequent increase in cost of living based on the recommendations of the High Power Committee. In the Government order 6<sup>th</sup> read above, orders were issued revising the rate of House Rent Allowance as recommended by the Pay Revision Commission, 1999.

2. In the Government Order 9<sup>th</sup> read above, orders were issued revising the pay scales of the State Government employees as recommended by the Pay Revision Commissioner, 2005, with effect from **1-7-2003** with monetary benefit from **1-4-2005**.

4. In the G.O 10<sup>th</sup> read above, Government have accepted the recommendations of the Pay Revision Commission, 2005 so far as House Rent Allowance is concerned and accordingly ordered for revision of House Rent Allowance as detailed therein.

5. The Government, based on the agreement with the Joint Action Committee of Employees, Teachers and Workers and A.P. Secretariat Employees Coordination Committee, have agreed to appoint a Committee for resolution of certain further demands raised by the Joint Action Committee.

6. The Government accordingly, appointed Sri N. Rangachary, Advisor to Government, Finance Department, as Chairman, One Man Committee in the G.O. 11<sup>th</sup> read above with the terms of reference as laid down therein.

7. The One Man Committee submitted its report to the Government. The Government after careful examination of the report, decided to implement certain recommendations of the One Man Committee and accordingly issued orders in the 12<sup>th</sup> read above, among which one of the recommendations was revision of ceiling on HRA from Rs.3000/- p.m. to Rs.4000/- p.m. from the date of issue of orders.

8. The Government in the G.O.13<sup>th</sup> read above issued order implementing the revised Master Scale recommended by One Man Committee and revising the pay scales with effect from 1-7-2003 with monetary benefit from 1-4-2005.

9. The Government accordingly hereby order for revision of the ceiling on H.R.A from Rs.3000/- p.m to Rs.4000/- p.m. from 1<sup>st</sup> June, 2006.

10. The other conditions laid down at paras 5 to 7 and 9 & 10 of the G.O. 10<sup>th</sup> read above shall hold good.

### **NOTIFICATION**

2. The amendments hereby made shall come into force on or from 1<sup>st</sup> June, 2006.

## **AMENDMENTS**

In rule 2 of the said Rules, in clause (a), clause (b) and clause (c) of sub-rule (1) for the existing figures and words “Rs.3,000/- per month”, the figures and words “Rs.4,000/- per month” shall be substituted .
