ORDER:

As per rule 7 of the Andhra Pradesh Backward Classes Welfare Subordinate Service Rules, 1996 issued in the reference 1st read above, the upper age limit for Direct Recruitment is 28 years for the posts covered in the said rules.

2. In the reference 2nd read above, an amendment was issued to Rule12 of the Andhra Pradesh State and Subordinate Service Rules, 1996 raising the upper age limit to 34 years for the Direct Recruitment, and age concession is allowed to Scheduled Caste / Scheduled Tribe / Backward Class candidates / Physically handicapped persons/ persons who worked in the armed forces of the Indian Union / NCC / in-service State Government employees etc.,

3. Government have decided to raise the upper age limit to 34 years in respect of the posts covered in the reference 1st read above, in consonance with the orders issued in rule-12 (1) (a) (v) of the Andhra Pradesh State and Subordinate Service Rules, 1996 including the age concession in favour of Scheduled Caste / Scheduled Tribe / Backward Class candidates and Physically Handicapped persons over and above the upper age limit allowed in rule-12 of the said Rules, 1996.

4. Accordingly, the following amendment is issued to raise the upper age limit to 34 years for the posts covered under the Andhra Pradesh Backward Classes Welfare Subordinate Service Rules, 1996.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto, the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Backward Classes Welfare Subordinate Service Rules, 1996 issued in G.O.Ms.No.36, Backward Classes Welfare (P2) Department, dated: 09.07.1996 as subsequently amended from time to time:-

In rule 7 of the said rules, for the expression "28 years", the expression "34 years" shall be substituted.
