Sub:- School Education - Providing subject Teachers to the needy schools for improving SSC results 2010-11 - Certain instructions - Issued - Regarding.

Al the District Educational Officers in the State are informed that during review of the inspections and visits of Seniors officers discussed on 07-08-2010 with the Secretary Education and it is decided that the services of the subject teachers shall be utilized in the needy High Schools of Govt. / ZP in order to improve the Academic performance of X Class students, so as to increase the percentage of results in the ensuing SSC exams 2010-11.

In this context, the Guidelines to assess the shortage / need of subject teachers school wise and also to identify the subject teachers etc., for utilizing their services in needy schools, are issued hereunder:

- Duration of utilization of Services of a Teacher is from September, 2010 to March, 2011.
- Identification of subject teachers is as follows:
  - 1. Assess the need of subject teachers High School wise for teaching X Class.
  - 2. Priority should be given to the High Schools where no single subject teachers are available.
  - 3. In case of two or more sections in a school and two or more teachers of same subject are working in the same school, there is no need of one more subject teacher. Utilize the services of one subject teacher to handle X Class either combining two sections or separate classes.
  - 4. In case, no single subject teacher is available in a school, utilize the services of needy subject teacher, from the nearby High School, where two subject teachers are working in the same mandal. For this the teacher who is handling the subject till today for X Class, should not be disturbed as it effects the continuity of the subject. Instead the services of 2<sup>nd</sup> subject teacher or newly recruited teacher shall be utilized in the needy school.
  - 5. If the 2<sup>nd</sup> subject teacher is not available in any High School in the same mandal, utilize the services of subject teacher of nearby mandal As far as possible, utilize the services of teacher from the nearby mandals in order to avoid hardship to the teachers.
  - 6. In case of shortage of Telugu / Hindi / Urdu Teachers for teaching of X Class, (a) utilize the services of 2<sup>nd</sup> teacher i.e. TPT/HPT / UPT of nearby High Schools of the same Mandal (b) utilize the services of TPT / HPT / UPT of Upper Primary School of same Mandal (c) if not available utilize the services of Teachers in the schools of nearby mandal.
  - 7. After taking up the above exercise and identifying the subject wise teachers for utilization of services school-wise.

In view of the above all the District Educational Officers in the State are requested to work out the above exercise and report compliance without fail.
