1. The executive and ministerial staff of Central Govt and Public Sector Undertakings be Categorised as Grade-I, II or III for the purpose of T. A. and D.A according to their Scale of Pay
 2. Where polling personnel are appointed from places beyond 300 Kms such personnel may be paid D. A. and T. A. admissible to them under the normal T. A. and D. A. rules applicable to them.
 They are also entitled to the benefit of 1/3 DA for the purpose.
 3. The officers put on duty at Distribution and Reception Centres will be paid flat rates of TA and DA as in the case of Presiding Officers/ Asst. Presiding Officers/ Polling Officers with reference to the pay range applicable to them.
 4. The polling personnel if any, detained for polling duty beyond four days may be paid normal D. A. admissible to their grade for each extra day of duty.
 5. The Jeep Drivers and other drivers deputed for polling duty may be paid Rs.2.50 over and above normal D. A. admissible to them.
 6. Class IV employees deputed for polling duty may be paid Rs.2.00 over and above the normal D. A. admissible to them.
 7. The Slab shall be calculated w.r.to the actual distance for which the officer incurs transportation cost and shall not include the distance for which free transport is arranged by Election Authorities.

SECTION OFFICER
