ORDER:

In the G.O.Ms.No.249, General Administration (SR) Department dated.20.06.2005 orders were issued enhancing the ceiling limit on reimbursement of medical expenses to the Members of Legislative Assembly/Ex-Members of Legislative Assembly as well as Members of Legislative Council/Ex-Members of Legislative Council and members of their families from Rs.75,000/- to Rs.1,00,000/- on par with Government (Serving) employees for the major ailments like Bypass Surgery, Kidney Transplantation etc. The Government have issued certain amendments through G.O.Ms.No.105, dt.09.04.2007 to the G.O.Ms.No.74, HM&FW (K1) Dept. dt.15.03.2005 and G.O.Ms.No.180, HM&FW(K1) Dept. dt.11.05.2006 respectively regarding package rates and enhanced the ceiling limit from Rs.1,00,000/- to Rs.2,00,000/- for major ailments and Rs.75,000/- to Rs.1,00,000/- for other treatments.

2. In the reference 8<sup>th</sup> read above, the Special Secretary to State Legislature, Legislature (MC) Secretariat has proposed to extend the facility of enhancement of ceiling limit of medical reimbursement from Rs.1.00 lakh to Rs.2.00 lakhs along with the packages enunciated in G.O.Ms.No.74, G.O.Ms.No.180 and G.O.Ms.No.105 of HM &FW (K1) Department, dt.15.3.2005, 11.5.2006 and 9.4.2007 respectively to all Members of Legislative Assembly/ Council and their families and to Ex – Legislators and their families.

3. Government after careful examination of the matter hereby enhance the medical reimbursement to Members of Legislative Assembly, Ex-Members of Legislative Assembly, Members of Legislative Council and Ex-Members of Legislature Council and members of their families from Rs.1,00,000/- to Rs.2,00,000/- on par with Government Serving employees for major ailments like Bypass Surgery, Kidney Transplantation, Cancer and Neuro Surgery and from Rs.75,000/- to Rs. 1,00,000/- lakhs for minor ailments, subject to such conditions as may be determined by the rules and Government also direct that they shall not be required to pay the amount in advance to the extent of the permissible amount on permissible items.

4. Necessary amendments shall be issued to the Andhra Pradesh Payment of Salaries and Pension and Removal of Disqualifications Act, 1953 (Act. II of 1954) and the Rules made there under.
