ORDER:

- 1. In the reference 1st read above, the Commissioner & Director of Municipal Administration, Hyderabad has requested to sanction (a) H.M Grade II 92 Posts, (b) School Assistants (non-languages) 1127 Posts to Municipal Management Schools.
- 2. In G.O.Ms.No. 363, Finance (SMPC) Dept., Dated: 10.11.2008, to strengthen the teaching staff in Government / Local Body (MPP/ZP/Municipal) Success Schools, Government have issued orders, to upgrade the 15584 posts of Secondary Grade Teachers to that of School Assistants and also created 17971 new posts of teachers i.e., 12210 School Assistants, 2206 Physical Education Teachers and 3555 language pandits respectively. In G.O.Ms.No. 14, Edn (SE TRG A3)Dept., dated: 25.01.2009 issued orders to upgrade 3933 pots of SGTs to that of H.M Grade II posts for strengthening the success and non success schools.
- 3. In the reference 2nd read above, the Commissioner and Director of School Education, Hyderabad has informed that, after allotment of the posts to the Districts Educational Officers, sanctioned in said GOs, the balance posts available are 139 H.M Grade II posts (by upgrading SGTs), 829 School Assistants Posts (newly sanctioned posts) 106 School Assistant Posts (by upgrading SGTs), and requested to allot the posts of 92 Gr.II Head Masters and 935 School Assistants from the balance posts now available to the Commissioner of Municipal Administration, Hyderabad.
- 4. Government after careful examination of the matter, hereby allot the following posts to the Municipal Administration and Urban Development Department for allotment the same to the Municipal Success Schools under their control.
