In the reference 1<sup>st</sup> cited, the Commissioner and Director of School Education, Hyderabad has stated that different faculty vacancies in DIETs / CTEs / IASEs and SCERT are not filled due to the Court Case on Unification of Services of Govt. and PR Teachers pending before the Hon'ble Supreme Court. He has further stated that there are huge number of posts of Lecturers i.e. in DIETs 385 posts, in CTEs 34 posts, in IASEs 7 posts and 31 posts in SCERT are vacant. He has stressed every need to fill these vacancies for quality in teacher education in the said Institutions.

In the ref. 2<sup>nd</sup> cited, the C&DSE has requested the Government for permission to fill the vacant posts of Lecturers in DIETs / CTEs / IASEs on deputation basis among the regular and qualified HMs Gr.II / School Assistants in the respective District according to subject requirement and duly following the qualifications prescribed in G.O. Ms. No. 505, Education, dated 16.11.1998 and G.O. Ms. No. 92, Education, dated 6.11.2007. He has further requested to permit him to depute the qualified persons (i.e. not below the rank of Gazetted HM or equivalent and above category) from all districts to work as Lecturers in SCERT, subject to the requirement and qualifications as prescribed in G.O. Ms. No. 505, dated 16.11.1998.

Government, after careful examination of the matter, hereby permit the C&DSE, Hyderabad to fill the vacant posts of Lecturers in DIETs / CTEs / IASEs and SCERT on the following terms and conditions:

1. Vacant posts of Lecturers in DIETs / CTEs / IASEs may be filled temporarily with the regular and qualified personnel in the rank of School Assistants / HM Gr.II to work on their own pay, from the respective district on deputation basis according to the requirement and qualifications prescribed in G.O. Ms. No. 505, Education, dated 16.11.1998 and G.O. Ms. No. 92, Education, dated 6.11.2007.
2. Vacant posts of Lecturers in SCERT may be filled temporarily with the regular and qualified personnel in the rank of HM Gr.II and above to work on their own pay from all districts on deputation basis according to the subject requirement and qualifications prescribed in G.O. Ms. No. 505, Education, dated 16.11.1998.
3. Personnel working in School Education Department will only be considered for deputation.
4. School Assts. / HMs Gr.II who are deputed to DIETs / CTEs / IASEs to work on their own pay are permitted to draw their salaries from the provision of vacant posts of Lecturers existing in DIETs / CTEs / IASEs.
5. HMs Gr.II and above who are deputed to SCERT to work on their own pay are permitted to draw their salaries from the provision of vacant Lecturer posts existing in SCERT.
6. The deputed personnel are permitted to continue on deputation till the Lecturer posts in DIETs / CTEs / IASEs / SCERT are filled by the regular candidates and they are deemed to have been relieved as and when these posts are filled on regular basis.

7. If number of applicants against a post are more, seniority and qualifications may be taken into the criteria for selection for deputation. The minimum service for eligibility is 5 years.
8. Deputed staff may be permitted to work on their own scale of pay with permissible allowances applicable to the place of DIET / CTE / IASE / SCERT and salary to be drawn from the provision of vacant Lecturers / Sr. Lecturers of DIET/CTE/IASE/SCERT.
9. Since medium offered in DIETs are Telugu and Urdu, the deputed staff should have passed X class/SSC in Telugu/Urdu medium or shall have passed X class/SSC with Telugu/Urdu as 1<sup>st</sup> language as the case may be.
10. Not only School Assistants but PGHM Gr.II can also be considered for deputation (who have possessed prescribed and requisite qualifications). When PGHMs are deputed, the resultant vacancy can be filled by a regular employee, so that functions of the School may not be affected.
11. Deputed staff shall submit an undertaking before their joining, that he/she will not claim any seniority/appointment at the time of filling up of posts by promotion to the Senior Lecturers/Lecturers, DIET, IASEs, CTEs, GCPEs SCERT in future. Repatriations will not be made on the request of the individual and it is only at the discretion of the Department and to the existing vacancies available at that time.
12. From now onwards, the regular staff of DIETs/CTEs/IASEs/SCERT shall not be deputed to other organizations.
