In continuation of this office proceedings under reference read above, all the Project Officers of RVM( SSA) in the state except Hyderabad and Visakhapatnam are informed that guidelines were already communicated to the concerned Project Officers with a request to communicate the same to the concerned Head Masters through Mandal Educational Officers concerned for effective implementation of the activity.

It is further informed that, during the Hon'ble Minister PE & SSA review meeting held at Dr. MCR HRD institute , Hyderabad on 31<sup>st</sup> August 2012, some of the Project Officers have brought to the notice of the Hon'ble Minister for PE &SSA that, bi-cycles may be provided to the children who don't have Upper Primary Schooling facility within 3 kms distance studying in Upper Primary stage i.e Class VI to VIII instead of paying transportation charges so that the children will use the bi-cycles up to secondary level. The Hon'ble Minister for PE & SSA agreed the said proposal and requested the State Project Director to collect the requirement of bi-cycles to the children studying in Upper Primary i.e, Class VI to VIII.

In view of this, all the Project Officers of RVM ( SSA) in the state except Hyderabad and Visakhapatnam are requested to furnish the proposals to the State Project Office by 30-09-2012 in the following proforma for providing of bi-cycles to the children without Upper Primary Schooling facility within 3 kms distance for taking necessary action.
